

Warning: High Commissions When Purchasing E-Vignettes from Unauthorized Sellers

We would like to warn users of Slovenian motorways and expressways to exercise caution when purchasing electronic vignettes online. We have detected an increasing number of cases in which unauthorized resellers offer Slovenian e-vignettes through misleading websites, exposing customers to additional costs and even the risk of being left without a valid E-vignette.

High Commissions and Risk of Abuse

Unauthorized sellers usually charge high commissions for their services, often amounting to several tens of percent, meaning that customers pay significantly more for the E-vignette than its actual legally prescribed price. In addition to financial loss, such purchases involve further risks:

- **Purchase not guaranteed:** the reseller may receive payment but fail to purchase the E-vignette from DARS on behalf of the customer;
- **Subsequent changes to data:** In cases where e-vignettes with a future validity date were purchased, we have detected instances in which sellers completed the purchase with DARS after payment had been made but later changed the vehicle registration number linked to the E-vignette without the customer's knowledge. As a result, the customer unknowingly remained without a valid E-vignette.

Who Are the Authorized Online Sellers?

To avoid misleading business practices, we emphasize that, in addition to the official website of the toll road operator DARS (evinjeta.dars.si), the following partners are currently the only authorized online sellers of Slovenian e-vignettes:

- ASFINAG (shop.asfinag.at)
- ADAC (www.adac.de/fahrzeugwelt/maut-vignette/)
- PETROL (<https://www.petrol.si/na-poti/za-vozilo/vinjete>, <https://www.petrol.hr/na-putu/za-vozilo/vinjete>)

Purchasing through any other website, which may often appear among the top search engine results, carries the risk of paying unnecessary additional costs or even becoming a victim of fraud.

Recommendation to Users

We would especially like to warn E-vignette buyers to be extremely cautious when clicking on search engine results. Unauthorized sellers often purchase advertising space, which causes their websites to

appear at the top of search results. Always check the website address (URL) to which the link directs you. If the address does not lead to the website of one of the official sellers listed above, leave the website immediately.

Only by purchasing through official channels will you pay the correct price for the E-vignette and ensure that the E-vignette is linked to the vehicle registration number that you entered into the system during the purchase process and for which you also received a purchase confirmation.
